ABOUT LEAP

LEAP was established in 1992 to advance racial equity by providing free social and academic enrichment, mentorship, and leadership opportunities for children and teens in New Haven's low-income neighborhoods. LEAP trains children in art, computer science, swimming, athletics, camping, cooking, and team building. LEAP will serve more than 1,200 children and will employ over 250 young people in 2023. We are New Haven's largest youth agency and youth employer.

Following a tremendous year of growth in the numbers of youth we can serve in 2022, LEAP now operates at eight community-based sites, including the LEAP Community Center on Jefferson Street and the newly opened Dixwell Q House that LEAP manages. In 2023, LEAP is focusing its work on deepening its afterschool and summer literacy and socialemotional curricula. Teens in the LEAP program are interns, working with LEAP counselors as classroom assistants and in so doing developing valuable teaching and mentorship skills. LEAP youth counselors receive personalized and small-group college application support through our revamped college access program, which continues to grow in 2023 as we provide support for admissions and the financial aid process. LEAP also plans to include a phonics component in its literacy-based program for children to help our youngest LEAPers become strong readers.
